TERMS AND CONDITIONS

USE OF IMAGES AND COPYRIGHT

- 1. All images produced by Arabella Futcher Photography are protected by Australian and international copyright. The client agrees that Arabella Futcher Photography owns the Copyright in all photographs. The client gives permission to Arabella Futcher Photography to use any image of the session for industry competitions and as required subsequent usage and for reasonable general promotional advertising for the Arabella Futcher Photography The usage for any other purpose (such as use on social media sites) can be negotiated and noted on the Model Portrait Release form.
- 2. As Arabella Futcher Photography owns the Copyright, when purchasing printed products and when viewing any unpurchased images online, the client agrees not to copy, cause to be copied or allow anyone else to copy, photocopy, laser copy, screenshot or scan any images. If clients purchase digital negatives, clients are granted authorisation to obtain unlimited reprints for personal use only. The photographs provided on the USB may not be sold, edited, altered (other than resizing for print) or used for any commercial purpose under any circumstances, without written permission. The client will use the photographs and negatives as agreed above and understand that by not doing so is a breach of this agreement.
- 3. Watermarked low resolution images may be provided on social media sites and Arabella Futcher Photography blog for the clients to share with friends and family. The client is welcome to tag themselves and share these images; however altering the image in any way, including cropping out the Arabella Futcher Photography watermark is a direct breach of Copyright. It is a breach of Copyright to screenshot any images and share them.
- 4. All purchased images will remain on file for 2 years. Due to file storage limitations, unpurchased images will be deleted on 31 December each year. Ordering further prints and products is available until that date.

SESSION FEES AND CHARGES

- 1. . A non-refundable Session Fee is due in order to secure the session date and time. Arabella Futcher Photography has the right to give the session date and time to another client if the session fee has not been received one week prior to the session.
- 2. The Session Fee includes up to 6 people in the session. Additional people will be an extra \$25 per person unless specifically negotiated.
- 3. Pricing of Prints, Frames & Digital Collections: Individual prints start at \$80 ,framed prints start at \$210 and digital collections start at \$700. The complete digital collection includes proof prints of every colour photograph from your session and all high resolution images provided in black & white and colour on USB. The complete digital collection is available for \$1600. There is a \$500 minimum spend.
- 4. The client acknowledges that they have read and understood Arabella Futcher Photography's pricing as per section 3, including minimum spend. Acknowledgement of this is confirmed via payment of the session fee.
- 5. In the event that the client needs to reschedule the date, Arabella Futcher Photography requires 24 hours notice. The Session Fee is transferable to another date within the following 12-month period. In the event of changes to the studio price list, prints and product pricing and availability for sessions will apply as at the newly booked date.
- 6. Your Life Through a Lens may reschedule the session if weather conditions will hinder the shoot (such as heavy rain). All attempts will be made to avoid this, however sometimes it is in the client's best interest to postpone to another date with better conditions.
- 7. Arabella Futcher Photography will provide an online gallery of proofs within 2 weeks of the session date unless otherwise notified. Orders are to be placed at the viewing session or online within 7days. The gallery automatically deactivates on the 7th day.
- 8. If circumstances arise that the client is unable to place their order during the initial 7 days, the gallery can be reactivated for one additional 7-day timeframe. Any further reactivations will charged a Reactivation Fee of \$50 per 7 day time slot, payable prior to reactivating the gallery.
- 9. Additional editing & Photoshop Work: Images shown in the client gallery include basic retouching (removal of blemishes, skin smoothing, reduction of dark lines under eyes). Further custom or client directed retouching is an additional \$20 per image.
- 10. Due to gallery limits and cost of storage, where an order has not been received and paid for within 30 days of first gallery expiry date, the images will be deleted.
- 11. All orders must be confirmed in writing and accompanied by full payment before any order will be placed.
